Back to the Nephilim

Gen 6:1 And it came to pass, when men began to multiply on the face of the earth, and daughters were born unto them, **Gen 6:2** That the sons of God saw the daughters of men that they *were* fair; and they took them wives of all which they chose. **Gen 6:3** And the LORD said, My spirit shall not always strive with man, for that he also *is* flesh: yet his days shall be an hundred and twenty years. **Gen 6:4** There were giants in the earth in those days; and also after that, when the sons of God came in unto the daughters of men, and they bare *children* to them, the same *became* mighty men which *were* of old, men of renown. (KJV)

[Deu 2:11](#) Which also were accounted [giants](#), as the Anakims; but the Moabites call them Emims.

[Deu 2:20](#) (That also was accounted a land of [giants](#): [giants](#) dwelt therein in old time; and the Ammonites call them Zamzummims;

[Deu 3:11](#) For only Og king of Bashan remained of the remnant of [giants](#); behold, his bedstead *was* a bedstead of iron; *is* it not in Rabbath of the children of Ammon? nine cubits *was* the length thereof, and four cubits the breadth of it, after the cubit of a man.

[Deu 3:13](#) And the rest of Gilead, and all Bashan, *being* the kingdom of Og, gave I unto the half tribe of Manasseh; all the region of Argob, with all Bashan, which was called the land of [giants](#).

[Jos 12:4](#) And the coast of Og king of Bashan, *which was* of the remnant of the [giants](#), that dwelt at Ashtaroth and at Edrei,

[Jos 13:12](#) All the kingdom of Og in Bashan, which reigned in Ashtaroth and in Edrei, who remained of the remnant of the [giants](#): for these did Moses smite, and cast them out.

[Jos 15:8](#) And the border went up by the valley of the son of Hinnom unto the south side of the Jebusite; the same *is* Jerusalem: and the border went up to the top of the mountain that *lieth* before the valley of Hinnom westward, which *is* at the end of the valley of the [giants](#) northward:

[Jos 17:15](#) And Joshua answered them, If thou *be* a great people, *then* get thee up to the wood *country*, and cut down for thyself there in the land of the Perizzites and of the [giants](#), if mount Ephraim be too narrow for thee.

[Jos 18:16](#) And the border came down to the end of the mountain that *lieth* before the valley of the son of Hinnom, *and* which *is* in the valley of the [giants](#) on the north, and descended to the valley of Hinnom, to the side of Jebusi on the south, and descended to Enrogel,

2Sa 21:16 And Ishbibenob, which *was* of the sons of the **giant**, the weight of whose spear *weighed* three hundred *shekels* of brass in weight, he being girded with a new *sword*, thought to have slain David.

2Sa 21:18 And it came to pass after this, that there was again a battle with the Philistines at Gob: then Sibbechai the Hushathite slew Saph, which *was* of the sons of the **giant**.

2Sa 21:20 And there was yet a battle in Gath, where was a man of *great* stature, that had on every hand six fingers, and on every foot six toes, four and twenty in number; and he also was born to the **giant**.

2Sa 21:22 These four were born to the **giant** in Gath, and fell by the hand of David, and by the hand of his servants.

1Ch 20:4 And it came to pass after this, that there arose war at Gezer with the Philistines; at which time Sibbechai the Hushathite slew Sippai, *that was* of the children of the **giant**: and they were subdued.

1Ch 20:6 And yet again there was war at Gath, where was a man of *great* stature, whose fingers and toes *were* four and twenty, six *on each hand*, and six *on each foot*: and he also was the son of the **giant**.

1Ch 20:8 These were born unto the **giant** in Gath; and they fell by the hand of David, and by the hand of his servants.

According to Deuteronomy 7:1 there are seven nations God forbade Israel to marry into or give in marriage to and if they did think to marry into these seven nations God would destroy the Israelites that did.

Deu 7:1 When the LORD thy God shall bring thee into the land whither thou goest to possess it, and hath cast out many nations before thee, the Hittites, and the Girgashites, and the Amorites, and the Canaanites, and the Perizzites, and the Hivites, and the Jebusites, seven nations greater and mightier than thou; **Deu 7:2** And when the LORD thy God shall deliver them before thee; thou shalt smite them, *and* utterly destroy them; **thou shalt make no covenant with them, nor shew mercy unto them:** **Deu 7:3 Neither shalt thou make marriages with them; thy daughter thou shalt not give unto his son, nor his daughter shalt thou take unto thy son.** **Deu 7:4** For they will turn away thy son from following me, that they may serve other gods: so will the anger of the LORD be kindled against you, and destroy thee suddenly.

So here is my conclusion:

Guys have been blindsided in our culture. We don't see the path to manhood, and we often don't know how to view women, sex, relationships, marriage, and our role as husbands.

A key to the problem guys face is that we don't understand the North Star of relationships. It's the gold standard of selfless love, the blueprint for building a family and blessing your children. What's that North Star? Knowing Jesus Christ and His purposes for marriage and trusting in His strength to make a lasting relationship possible.

Marriage needs to be re-explained. It needs to be re-branded as an awesome, noble, and challenging adventure. Our manhood, our happiness, and our children's future depend on marriage—yours, mine, and everybody else's.

In a culture of counterfeits and mistruths, it's important to understand what marriage is about. As you read through the following list, ask God to remake you and help you understand what it means to be a man and a husband. Let's value marriage and relate well to our wives, whether we're married yet, or preparing for that woman.

21 things about marriage

1. A man needs to know that the ultimate team is marriage.

It's the union and oneness of man and woman in lifelong covenant. It's the team that anchors a family. It's a bonded relationship that mirrors God's sacrificial, unconditional, lasting love for his children (those who by faith have accepted His sacrifice and adoption into his eternal family).

2. A man needs to know the difference between being a consumer and an investor in life, in relationships, and in marriage.

Don't let an advertising-saturated, consumer society make you act like a consumer in relationships. Decide to add value to a wife, not take value.

Just like great quarterbacks serve receivers, and great receivers serve quarterbacks, we need to be investors, not childish consumers, takers, or complainers. We are to model ourselves after Jesus, the ultimate relationship Investor. He is the definition of a man: responsible, initiating, courageous, self-sacrificing, healing, peacemaking, justice-doing, others-centered rather than self-centered, loving others in ways that add value and nobility to them.

Before he is married, a great husband will be a relationship investor who will build friendship that adds value into the life of a young woman, her self-esteem, and her potential to serve God. He will channel his sexual desires and expression into devotion to God and commitment to one wife for life. He will marry and be sexually exclusive—only having eyes, imagination, and sexual intimacy with one woman.

We should be asking ourselves this question daily: “Would I want to marry me?”

3. A man needs to know that a marriage and family depend upon God as their Maker.

God is the authority. He provides the blueprints for marriage and the power source of love, wisdom, and health. God can heal any marriage if the husband and wife will submit themselves to God and let Him change them.

4. A man needs to know that marriage is meant to mature him and develop Christ-like character in him.

It can help conform him to the image of Christ, reshaping his will and identity into union with, and deference toward, his wife. This is like the Father, Son, and Holy Spirit who honor, defer to, and glorify each other.

The friendship of marriage helps spouses become better versions of themselves, closer to what God designed and redeemed them to be. They must face the truth about themselves—their strengths and their imperfections. They will face conflict and difficulty and must grow empathy and teamwork. Selfishness must melt away if they are to become healthy, strong, and mature together.

5. A man needs to know the meaning of love.

God defines love not by how much you want to receive, but by how much you are willing to give of yourself—your will, your freedom, your time, your emotions, your forgiveness, your resources. The model is Jesus, who demonstrated love for us by dying for us while we were yet sinners.

A husband does this by choosing his wife as a priority in his life over all other pursuits, possessions, and distractions—regardless of whether she is kind, lovable, or respectful. Love brings out the best in her. A man initiates love, rather than waiting for or demanding respect or kind treatment. Love is not dependent upon feelings. Decisions and choices to love can regenerate the feelings of love.

6. A man needs to know the Christ-like role of servant, husband, and lover.

He is to be an investor in his wife, and he sacrifices himself for her best. He defines his manhood as pursuing purity in Christ, chastity before marriage, and enthusiastic fidelity in marriage.

7. A man needs to understand sexuality as God’s good creation, distinct from its counterfeits.

He understands that sexuality makes sense in the context of union to God and the union of marriage. Outside that context it’s often reduced to moralism, rules, suppression, secrecy, illicit imagination, temptation, and shame. Or commonly it’s reduced to a consumer experience—materialistic self-interest, physical gratification, entertainment, techniques. This causes shallow, stunted human bonding, untold stories of abuse, damage, abandonment, and fragmented families.

8. A man needs to know that the key to great sex is exclusivity.

Our modern world tricks a man into thinking that more sources of sexual stimulation will satisfy him. But like a drug, they thrill but do not satisfy. Sexual entertainment, images, and illicit sex erode rather than enhance sexual joy in a marriage.

The way to become a great lover is to practice with only one woman for life. It is to be generous, exclusive, and serving—not greedy, distracted, and taking. A great relationship and great sex are connected in marriage, and that only happens when a man’s sole target of sexual affections, imaginations, and enjoyment is his wife.

9. A man needs to know that marriages typically have a one- or two-year “honeymoon era.”

This is a period of semi-blind euphoria that makes the relationship magnetic and easier. It’s as if our Creator gives that to us humans to get us jump-started in marriage. Couples should know that when the euphoria wears off and they eventually settle into normality, the different feelings they experience do not indicate that they married the wrong person or are not “in love” anymore.

10. A man needs to know that living together and having sex before marriage uses up a good portion of the “honeymoon era” euphoria.

It often causes the onset of reality to begin almost immediately after the wedding, depending on how long the couple had been living and sleeping together. Research shows that divorce and issues of mistrust are more common for those who cohabit before marriage than for those who do not. Cohabiting is not “good practice” for marriage.

11. A man needs to know that commitment is a key to success in all of life, and especially in a relationship with a woman.

One way of defining commitment in marriage is never considering divorce. If you know that you won't be leaving or divorcing, it forces you to face differences and problems and work through them.

In marriage it is the security of commitment that allows a woman to feel peace in the relationship. The assurance of a husband's commitment helps a woman entrust herself to him emotionally and sexually.

12. A man needs to know that marriage is not easy.

Marriage is not automatic, and it's often difficult. The euphoria of romantic infatuation in the first years of marriage fades, requiring the mature resolve to behave lovingly and invest relationally to build a deeper bond than infatuation. Marriage will take intentional and continual effort.

13. A man needs to know that the purpose of marriage is less to make you happy, than to make you holy.

Now it's true that a good marriage to a good woman can make you happier than most anything else on earth. But if your goal is to be happy, then you will be focused on yourself, and you will damage your character and your relationships.

If you aim to be holy—like Jesus, not like a monk—you will invite God to change you. You will allow your marriage relationship to change you and crush your selfish will and defensive pride. You will experience true oneness in your marriage—you'll be deepest friends, intimate allies, generous lovers, caring providers, complementary partners, spiritual enhancers. (This concept included by the author with permission from Gary Thomas.)

14. A man needs to know that God gives authority and responsibility to a husband to make the marriage thrive and last.

He is to steward and shepherd himself and his wife's union. He is to be proactive at assisting God in healing her past wounds, creating oneness in their bond, and assuring her (and their children) of his love for her.

Women are natural responders when men initiate in love, prayer, and humility. Men must not be passive, arrogant, distracted, or controlling. A man will not point the finger at his wife's behavior or shortcomings but will examine his history as a husband and ask God to change him. His heart, his care, and his initiative is the key to his wife's response and the health of the marriage.

15. A man needs to know that he can change his marriage by changing himself.

He can make himself a better husband by making himself a more consistent and devoted follower of Jesus. If he wants to improve any aspect of his marriage—family or parenting—the solution lies in deepening his daily commitment to God. The path to build a great marriage or to heal a marriage is for him to humble his will, to let the Holy Spirit take control of him, and to obey Christ.

16. A man needs to know that romance is created and sustained intentionally.

Thinking about what she likes, remembering what is important to her, setting things up the way she prefers ... these are all critical. In dating and various stages of life, romance can spontaneously happen; but for the long term, it must be deliberately planned and created. If a man wants to be a leader, this is an area in which to lead. And it leads to good things.

17. A man needs to know that divorce is avoidable.

He understands that nothing is impossible for God, and he humbles himself to admit and repent from the ways he fell short in loving his wife in the past, so he can excel at loving her from this day forward.

18. A man needs to know that he can recover from a wife’s affair because he has the power to forgive.

Jesus forgave all his sin, and he is called to do the same with his wife. Furthermore, he seeks to understand what led his wife to be unfaithful, even if it means admitting his own failure. Usually, a man breaks his vow to choose, love, and protect her before a woman breaks her vow to be faithful.

Note: If you have an affair, you don’t have control over whether you can recover because you can’t force a wife’s forgiveness.

19. A man needs to know that even the worst things can be redeemed for deeper purposes.

Romans 5:3-5 reminds us to rejoice and find value in tribulation, loss, and suffering because tribulation brings perseverance, and perseverance brings proven character like that of Jesus, and proven character brings hope, and hope does not disappoint because God’s love is poured out to us by His Holy Spirit.

Face crises and trials and suffering straight on with Christ and a few close teammates. A man steps up, by surrendering to Jesus Christ and persevering in making Him the center and Lord of his life.

20. A man needs to know that humbling himself to his wife is the gutsiest and most successful way to heal her heart and the frequently compromised relationship.

A man with courage and wisdom will never overlook his wife’s hurt feelings. And he’ll seek to overlook the disrespectful words she blurts out in reaction to how he hurt her feelings.

When you are in conflict, don’t wait for things to blow over. Don’t try to point out her fault. Don’t try to minimize the situation. And don’t defend yourself. Instead, be a leader. Start the apology. A great starting point is, “I was wrong. I hurt you. Please forgive me?”

21. A man needs to know that a wife wants him to lead her but will tend to lead and control him if he doesn’t lead and initiate.

Leadership starts with your character and your devotion to Christ. Your walk with God determines the quality of your love and leadership as a husband.

Seek God. Read His word in the Bible. Pray for Him to shape and lead you. Humble yourself before Him. Seek a mentor or group to help you grow and become a good husband.

Leadership of a wife is humility before God, initiating teamwork with your wife, praying with her every day, and praying for your family. Most guys I know well are like me in this: If you’re frustrated with your wife and your marriage, the solution lies in getting back into Jesus and His Word!

Tithing on the “Increase”

What is Biblical “increase”? Money earned, agricultural produce? The most common belief is that any money earned is Scriptural increase and must be tithed on; ten percent given to someone or a group. This belief crosses most religious lines and is often emotionally charged when challenged.

Another, perhaps not as well publicized view, directly affects agriculture by teaching that tithes of produce (animal or plant) can be sold, and the money given as the tithe.

A third minority belief says Scriptural increase refers only to agricultural products, and only they must be given as tithes.

Once that old Middle English word “increase” (KJV; Strong’s Lexicon #8393), is Biblically defined, then we can decide which of these three beliefs is Scriptural.

The Word

The Hebrew (תְּבוּאָה *tebuaw*; SEC #8393) is translated in the KJV as “increase” (23 times; Deut. 14:22, 28; 16:15; 26:12....; KJV); “fruit” (6 times as produce and 1 time as “efforts of the wicked”), “gain” (1), and “revenue” (5).

When translated as “increase” and “fruit” those 29 times, it always refers to *agricultural produce*. The other seven [fruit (1), gain (1), revenue (5)] do not refer to produce of the land.

Clearly, in the KJV *tebuaw* is translated “increase” and “fruit” over eighty percent of the time and refers to agricultural produce.

Typically, verses using “increase” are interpreted as, “any gain gotten by productive effort.” Money is nearly always included as “gain” in such discussions of Biblical tithing. Usually the caveat is added that “increase” means the profit, the gain, after costs are deducted.

For example, the farmer would tithe (give ten percent) only on the net crop value after deducting all expenses incurred. Or perhaps the wage earner could deduct such work expenses as travel, clothing, food.

Is this the Biblical meaning of “increase” in such verses as: “You shall truly tithe all the increase (SEC #8393) of thy seed (SEC #2233), that the field (SEC #7704) bringeth forth year-by-year.” (Deut. 14:22; or v. 28; and Deut. 26:12; KJV)?

Compare this King James Version translation using “increase” (SEC #8393), with these translations of the same word: “produce, crop” (Moffat); “yield, produce, fruit” (RSV); “what your fields produce” (NJB); “produce” (NAS).

Corrupting the Scriptures

The word “increase” used in the King James Version and the earlier Geneva Bible is from the Old Middle English used during the period from c. 1150 A.D. to c.1475 A.D. It meant exclusively *agricultural produce*. Old English word meanings did not suddenly change when the Geneva Bible (1560 A.D.) or the later King James Version (1611 A.D.) were published. Both are clearly Old Middle English versions and their use of the Old English word, “increase”, meant only agricultural produce.

Expanding the meaning to “any gain gotten by productive effort” corrupts the meaning of “increase” to include.... *money*. In doing so, this misuse of the term opens the treasure chests of millions of bank accounts of unsuspecting followers who are fleeced with every paycheck.

This corruption is not without consequences. Religion is now more about big business, opulent buildings and colleges, and a privileged class of elite preachers, and less about the true gospel, and the faith once delivered to the saints. This statement could be tested by simply drying up the money pipeline and observing the result: Quit writing tithing checks and see how unwelcome you become.

Modern scholars, knowing whereof they speak from their knowledge of language, leave no doubt that *agricultural produce* is the proper translation of “increase” (SEC #8393) when referring to tithing.

Genesis Record Clarifies

But if there is an account comparing “increase” (KJV) with other facts related to crop production, the caveat that “increase” means profit can be decided right or wrong.

There is such a record in Genesis showing the truth about the Hebrew word translated “increase” (SEC #8393): “Here is

seed (SEC #2233) for you, and you shall sow the land (v. 23)...And it shall come to pass in the increase (SEC #8393)...give the fifth part to Pharaoh, and four parts shall be your own, for the seed of the field, and for your food...(v.24).” (Gen. 47:19-24).

Clearly, the “increase” included the total yield ($1/5 + 4/5 =$ the whole). No “profit margin.”

The source of the “increase” divided between Pharaoh and people working the land was the *seed* and *sowing the land*. The “gain from productive effort” was the total yield of produce.

Obvious too, is that *money is in no way stated nor implied* in the term “increase”; only what the land produced from the seed planted. This account is clear. We just have to accept what it says.

Tithing on Money

One correspondent, who tithes on his paycheck, stated that tithing on money was no burden because it was Scriptural. Those receiving the money simply convinced him they have the right to tax him ten percent.

The group taxing him calls those “misguided”, who teach that only agricultural produce is to be tithed on. Is the Bible misguided? The record is plain: “...the tithe of the land (SEC #776)...seed of the land (SEC #776) or,... fruit of the trees...herd...or the flock...is holy to Yahweh” (Lev. 27:30, 32), — agricultural produce. Again, where is money mentioned?

Productive Effort: Bible’s Command or Man’s Demand?

That expression, “productive effort”, is often used with a non-Biblical definition of “field” as the primary basis of teaching tithing on money as “increase.” It goes something like this, “People work in many fields such as electronics, factory work...and the Bible demands a tithe of their productive effort, their produce, of that field.” So, their “increase” becomes their earned income. This usually refers to Deut. 14:22: “You shall truly tithe all the increase of thy seed, that the field bringeth forth year by year.” (cited earlier).

Clearly, one contemporary meaning of the word “field,” [“a realm of knowledge or special work”; *Webster*] is applied to a Hebrew word (“field”; SEC #7704), that simply means “a plot of ground.”

Laws of Tithing: First Law Never Mentions Money

This misunderstanding about tithing is cleared up by using definitions from Yahweh’s Law that will free us from manmade rules. We can then see *His laws* of tithing for ourselves. Scriptural tithing is a multiple-tithe system).

The first-tithe law is found in Leviticus 27:30, 32: “And all the tithe (SEC #4643; a tenth) of the land (SEC #776), whether it be seed (SEC #2233) of the land (SEC #776) or of the fruit (SEC #6529) of the trees (SEC #6086), is Yahweh’s, it is holy to Yahweh” (v. 30). “And concerning the tithe (SEC #4643) of the herd (SEC #1241), or the flock (SEC #6629), even whatsoever passes under the rod, the tenth (SEC #6224) is holy to Yahweh” (v. 32). *Notice nowhere is money* (SEC #3701; silver) mentioned in these laws defining tithing. Not even once. Land, trees, seeds, flocks, herds are not money, not silver. Agricultural produce has value for sure. But it is not Biblical money.

When Money is Mentioned

Did Yahweh forget to include money in the tithing commands? Hardly. Money is very much a part of the Biblical record, but it never means seed of the land, fruit of trees, flocks, or herds; what is tithed on.

Notice several examples: “...I bought the field and weighed...out the money (SEC #3701; silver): seventeen silver shekels” (Jer. 32:9). “...So David bought the threshing floor and... oxen for fifty shekels of silver [SEC #3701]” (II Sam. 24:24). [a shekel is 0.552 oz.]. By Law money was paid in silver shekels.

Abraham bought a field with silver money: “...I will give you money [SEC #3701] for the field” (Gen. 23:13). Money was used to pay wages and make purchases: “...paid this money...to the masters of works... and these in turn spent it on carpenters and builders...on masons...stone-cutters, and on buying timber and dressed stone...” (II Ki. 12:12-13).

Clearly, the use of money as a medium of exchange is in the Biblical record. But no command required those wage

earnings to give a tenth of their money earned to *anyone* as Biblical increase. The distinction between land, fruit trees, flocks, seeds, herds and Biblical money could not be more clear.

Tithe Exchanged for Money

Notice how the Bible contrasts the two; showing they are not the same: “And you shall eat in the presence of Yahweh...the tithe of your grain, your new wine, your oil...And if the distance is so great...you are not able to bring the tithe...[notice] then *YOU SHALL EXCHANGE IT FOR MONEY* (SEC #3701) and bind the *MONEY* in your hand and go...” (Deut. 14:24-25; NAS). No other verse links tithing with money; only this lone verse. Clearly, if the tithe was money, it would not be exchanged for money.

This tithe is a second tenth of produce, **used by the grower**, that can be sold, and the money spent at Yahweh’s festivals. However, there is no law that allows exchanging a *first tithe* of produce for money. So, farmers could not legally sell their first tithe of produce (required: Lev. 27:30,32), and give the money as their “tithe”. That would be adding to the law (Deut. 12:32).

Only the second-tithe command (Deut. 14:24-25) allows exchanging agricultural produce for money which belongs to the grower for *his use* at annual festivals; not handed over to some religious group.

Freewill Offerings

There are commanded freewill offerings, however, that can be given in money (silver, gold, other currency), but no set percentage is stated (Ezra 8:28; Deut.16:10). Scripture clearly separates freewill offerings from tithes on produce, firstlings, etc. (Deut. 12:5,6). Recall Malachi 3:8-9: “...Yet you have robbed me...In tithes and *offerings*...even this whole nation.”; including farmers and others.

Freewill offerings are given on the New Moons and other occasions in the year. For example, in the three annual Festivals *all* males must appear before Yahweh, not appearing empty, but giving (no set percentage) as they have been blessed (Deut. 16:16-17). If not blessed with agricultural produce, then giving from blessings of money earned is acceptable.

Also, during the Feast of Weeks, freewill offerings are required once each week of that seven-week feast as clearly shown in Deut. 16:10: “And you shall celebrate the Feast of Weeks to Yahweh your Elohim with a tribute of a freewill offering of your hand just as Yahweh your Elohim blesses you.” (NAS).

Conclusion

Twisting and redefining Scriptures to push the tithing-on-money doctrine is common, and big business. Collecting illegal “tithes” on money gotten from the sale of agricultural produce rather than the produce itself is one example. Then, of course, there is the unscriptural demand that all money earned as wages, salaries, commissions, or from retirement accounts, social security, investments, etc. must be tithed on.

Peter warns us that some will pervert Scripture: “...they that are unlearned and unstable wrest (*twist, turn around*) [referring to Paul’s writings], as *they do also, the other scriptures*, unto their own destruction.” (2 Pet. 3:16).

When money is involved, beware, especially when tithing is the subject (Matt. 7:15).

Now you know that Biblical increase is not money. You have read the Bible *facts*. So, you decide if you owe ten percent of your paycheck to some religious group. Is tithing on your paycheck Yahweh’s command or man’s demand? After all, it’s *your money*.

Did Noah's Flood Cover the Himalayan Mountains?

Few doctrines in Scripture are as clearly taught as the global nature of the Great Flood in Noah's day. Genesis clearly teaches that *"the waters . . . increased greatly . . . and the mountains were covered"* (Genesis 7:18-20).

Through the centuries, few Christians questioned this doctrine. The Bible said it, and that was enough—until the late 1700s that is. For the first time the globe was being explored—the extremely lofty Himalayan Mountains were surveyed, capped by Mt. Everest at 29,035 feet in elevation. Did the waters cover them? Is there enough water on the planet to do so? The questions seemed so far-fetched that many European churchmen dismissed the idea that the Flood was global, adopting the local flood concept which still dominates Christian colleges and seminaries today. Like dominos, other doctrines soon began to fall—the young age for the earth, the special creation of plants and animals, and the inerrancy of Scripture.

We now know, of course, that the earth has plenty of water to launch a global flood. It has been calculated that if the earth's surface were completely flat, with no high mountains and no deep ocean basins, that water would cover the earth to a depth of about 8,000 feet. But is there enough water to cover a 29,035 foot mountain?

The key is to remember that the Flood didn't have to cover the present Earth, but it did have to cover the pre-Flood Earth, and the Bible teaches that the Flood fully restructured the earth. *"The world that then was, being overflowed with water, perished"* (II Peter 3:6). It is gone forever. The earth of today was radically altered by that global event.

That Flood accomplished abundant geologic work. Eroding sediments here, redepositing them there, pushing up continents, elevating plateaus, denuding terrains, etc., so that the earth today is quite different from before. Today even mountain ranges rise high above the sea.

Mt. Everest and the Himalayan range, along with the Alps, the Rockies, the Appalachians, the Andes, and most of the world's other mountains are composed of ocean-bottom sediments, full of marine fossils laid down by the Flood. Mt. Everest itself has clam fossils at its summit. These rock layers cover an extensive area, including much of Asia. They give every indication of resulting from cataclysmic water processes. These are the kinds of deposits we would expect to result from the worldwide, world-destroying Flood of Noah's day.

At the end of the Flood, after thick sequences of sediments had accumulated, the Indian subcontinent evidently collided with Asia, crumpling the sediments into mountains. Today they stand as giants—folded and fractured layers of ocean-bottom sediments at high elevations. No, Noah's Flood didn't cover the Himalayas, it formed them!

Thus, we find the Biblical account not only possible, but also supported by the evidence. A pre-Flood world with lessened topographic extremes could have been covered by the Great Flood. That Flood caused today's high mountains and deep oceans making such a flood impossible to repeat. This is just as God promised, back in Genesis.

The Money Balloon

As a child I could travel several miles into town by bus for half of an 'old penny', and 'sixpence' bought my weekly comic and sweets. The home in which I grew up cost £450 (new), and an aunt paid seven shillings and sixpence weekly rent. My Dad had a good income of £40 per week and we lived comfortably. The Bank of England calculates that as £350

today—so what happened? (Today’s average wage is £584.)

In 1978 a gallon of petrol was 75p, and today hovers around £7. That’s inflation, and it averages over 5% annual increase with some years being much higher. During wars— and in preparation for a war— when a nation borrows, inflation soars as in 1930’s Germany, while by mismanagement in Zimbabwe (2008) inflation rose to two million percent. It is in effect a tax, reducing the value of savings and destroying lives—and nations. World debt has almost reached 300 trillion dollars. (Where does the interest go?).

It’s a sorry fact that governments welcome inflation as, especially in times of crisis, it reduces the value of public debt—there’s less to pay back. (The current UK public debt tops two *trillion* pounds.) It is, however, devastating for those on a fixed income (e.g., pensioners) as the basic commodities inexorably rise in price.

For those able to save for a rainy day, money committed to the bank for safe-keeping (which the banks profitably lend) draws almost zero interest—and may soon cost the saver negative interest (*i.e.*, you pay the bank to look after it).

It is almost inevitable that the world’s financial house is on the brink of collapse. It is built on the crumbling foundation of debt, greed, and covetousness. Nations *may* weather this catastrophic storm—for now, but its ultimate destructive force will precipitate financial collapse: ‘...*They shall throw their silver in the streets, and their gold shall be an impure thing. Their silver and their gold shall not be able to deliver them in the day of the wrath of Jehovah*’ (Ezekiel 7:19).

It is prudent that, when possible, we be cushioned financially and that we enjoy and use wisely the fruit of our labour. Yet we live with the knowledge that our real support is in God (‘...*give us this day our daily bread*’), and that whatever resources we may have accrued is destined to be swept away in the debris of a fallen world.

This article was a great article on tithing. The part I sometimes hate is when people want to slide other subjects or opinions into a really good article.

Quote from Gary Millers article toward the end:

If not blessed with agricultural produce, then giving from blessings of money earned is acceptable.

Also, during the **Feast of Weeks**, freewill offerings are required once each week of that seven-week feast as clearly shown in Deut. 16:10: "And you shall celebrate the Feast of Weeks to Yahweh your Elohim with a tribute of a freewill offering of your hand just as Yahweh your Elohim blesses you." The parts I believe are not biblical I have highlighted in yellow. Let's take Deut. 16:10 first. We are being told that Deut. 16:10 clearly says freewill offerings are required once each week of the seven-week period. I am sorry, but I am just not seeing that command in this verse. Perhaps there is a command for that someplace else in scripture, but it is not in this verse, and I have never heard of this command before.

Deu 16:10 And thou shalt keep the feast of weeks unto the LORD thy God with a tribute of a freewill offering of thine hand, which thou shalt give *unto the LORD thy God*, according as the LORD thy God hath blessed thee:

Don't get me wrong here, I sincerely believe people should give freewill offerings on any day they want to give one, however when you say this particular freewill offering is required every week for the seven weeks then you need to give us proof and Deut. 16:10 just does not give any proof of this command if it even exists.

When the term feast of weeks is used here it is talking about Pentecost.

Gary mentions freewill offerings being given on the "New Moons" and again you can give a freewill offering on whatever day you want to give it. Some in the church treat new moon days as if they are holy days when they are not. There is no command to keep new moon days or a need to require a freewill offering on the new moons which would be the first day of each month. Gary does not specifically give a scripture for this requirement or need to give a freewill offering on the new moons, so I will throw one into the mix here. First lets look at how translators do things.

NEW MOON - 'CHODESH'

The Hebrew word '*chodesh*' corresponds to Strong's Exhaustive Concordance reference 2320.

What we can notice is the three references 2818, 2019 & 2320 only differ according to the assumed vowels. As vowels are not present in the received Hebrew Old Covenant the scriptural context is used by translators to decide the most appropriate rendering. We can also notice that all three words essentially carry the notion of 'new'. Only Strong's reference 2320 has a meaning of 'month'.

Hence, Strong's Exhaustive Concordance 2320 does not strictly mean 'new moon'. Rather it means 'month'. So, when a translation of 'month' (or 'new') does not make sense then the expression 'new month' would have been appropriate. However, since it has been commonly accepted that Jewish months were lunar based the translation "new moon" has become normal.

In any, case, one should not try to prove the existence of a literal 'New Moon' solely using this Hebrew word.

In practice the Hebrew word, corresponding to '2320', has been rendered:

- 'month': The most common translation of the word 'chodesh' is simply as 'month'.
- 'New Moon': Translators noticing that Scripture uses the word 'chodesh' in a second religious context have chosen in these cases to simply render the Hebrew word as 'New Moon'.

The notion 'New Moon' has generally been viewed at a literal level. Nevertheless, there is reason to believe this term is being applied figuratively to reflect new phases in the plan of God!

[NB: It is worth noting that the symbol of the 'moon' is also used in a symbolic manner in Scripture (refer, Gen 37:9-10, Psalm 121:6, 148:3 and Rev 12:1). The moon is often thought to represent the feminine aspect of the church; due to the fact that the moon does not generate its own light but rather reflects the light of the sun (which is a symbol for Christ).]

The Hebrew does have a word for 'moon', Strong's reference 3394. So, if Scripture wanted to clearly refer to a "new moon" it could have done so by combining the Strong's references 2318 and 3394.

What we can observe is that translators have elected to render the Hebrew 2320 as 'month' unless the rendering would not make sense. Therefore, it is likely they have in some cases confused the true meaning of some verses. By incorrectly rendering 'month' when 'New Moon' (or 'New Month') was actually being discussed. (End Quote)

One verse that is used to try to prove that new moons are to be kept is Ezra 3:5:

Ezr 3:5 And afterward *offered* the continual burnt offering, both of the **new moons**, and of all the set feasts of the LORD that were consecrated, and of every one that willingly offered a freewill offering unto the LORD.

If you look at this same verse in other bible translations, some of them have rendered “new moons” as “new moon” which in context makes more sense.

In verse four it says they are making all the daily offerings and in verse six they are telling you when the offerings started. Bible translators do not as a general rule always have God’s Holy Spirit nor do most of them keep any of the Holy Days. So here they put “new moons” when they should have put “new moon”. Had it been translated correctly it would have been in reference to verse six where it is clearly talking about the Feast of Trumpets which is on the first day of the seventh month. Which is a new moon day and a high holy day.

Ezr 3:4 They kept also the feast of tabernacles, as *it is* written, and *offered* the daily burnt offerings by number, according to the custom, as the duty of every day required;

Ezr 3:5 And afterward *offered* the continual burnt offering, both of the new moons, and of all the set feasts of the LORD that were consecrated, and of every one that willingly offered a freewill offering unto the LORD.

Ezr 3:6 From the first day of the seventh month began they to offer burnt offerings unto the LORD. But the foundation of the temple of the LORD was not *yet* laid.

Ezra 3:5 is not the only place in scripture where I have seen them list new moon and then reference the other high holy days separately. In my opinion it is done this way in order to put more emphasis on the first day of the seventh month because in Hebrew it is known as the “Chief” month, the one that the entire Hebrew Calendar is set from.
